EDUCATION THROUGH MUSIC (ETM) WAS FORMED TO PROMOTE THE USE OF MUSIC IN THE CORE CURRICULA OF UNDER-RESOURCED SCHOOLS AS A MEANS OF POSITIVELY IMPACTING STUDENT MOTIVATION, ACHIEVEMENT, AND SELF-CONFIDENCE. BY PROVIDING YEAR-LONG, IN-SCHOOL MUSIC EDUCATION PROGRAMS WITH A DEDICATED STAFF OF TEACHERS AND SUPPORT MANAGEMENT, ETM MAKES MUSIC EDUCATION A REALITY FOR THOUSANDS OF CHILDREN WHO WOULD OTHERWISE HAVE LIMITED OR NO EXPOSURE TO MUSIC INSTRUCTION AT SCHOOL. DURING 2022-23, ETM'S PARTNER SCHOOL PROGRAM PROVIDED COMPREHENSIVE, DIRECT MUSIC INSTRUCTION TO OVER 21,000 CHILDREN IN NEW YORK CITY, AND ETM ASSISTED ITS LICENSED AFFILIATE PROGRAMS IN IMPROVING THEIR OWN ACTIVITIES.

PROGRAM SERVICE ACCOMPLISHMENTS 2022-23 DURING THE 2022-2023 SCHOOL YEAR, EDUCATION THROUGH MUSIC WORKED TO SUPPORT STUDENT LEARNING AND ENGAGEMENT, WHILE BUILDING CAPACITY AMONG SCHOOL AND COMMUNITY MEMBERS TO CREATE SUSTAINABLE MUSIC PROGRAMS. ETM DELIVERED MUSIC CLASSES TO OVER 21,000 CHILDREN AT 63 SCHOOLS IN LOWER-INCOME NEW YORK CITY NEIGHBORHOODS, PRIMARILY SERVING BIPOC COMMUNITIES. OF THE STUDENTS SERVED, APPROXIMATELY 22% HAD SPECIAL NEEDS, 15% WERE ENGLISH LANGUAGE LEARNERS, AND 85% WERE LIVING BELOW THE POVERTY LINE. 93% OF ETM STUDENTS WERE PEOPLE OF COLOR: 56% HISPANIC, 28% BLACK, AND 7% ASIAN (AS CATEGORIZED IN SCHOOL CENSUS REPORTS). THESE 63 PARTNER SCHOOLS WERE LOCATED IN ALL FIVE NEW YORK CITY BOROUGHES: 39 BRONX, 6 BROOKLYN, 4 MANHATTAN, 10 QUEENS, AND 4 STATEN ISLAND, ALLOWING US TO WORK WITH MORE THAN 21,000 CHILDREN EACH WEEK, WHICH INCLUDED 30+ BAND, ORCHESTRA, AND CHORUS PROGRAMS. ETM'S PROGRAMS PROVIDED:- STUDENTS WITH ACCESS TO COMPREHENSIVE, SEQUENTIAL, AND SKILLS-, AND STANDARDS-BASED MUSIC INSTRUCTION AS WELL AS ENRICHMENT PROGRAMS.- MUSIC TEACHERS WITH ONGOING TRAINING, MENTORING, AND OVERSIGHT.- CLASSROOM TEACHERS WITH PROFESSIONAL DEVELOPMENT.- PRINCIPALS WITH LEADERSHIP AND PROGRAM MANAGEMENT GUIDANCE.- PARENTS AND COMMUNITY MEMBERS WITH OPPORTUNITIES TO LEARN ABOUT MUSIC EDUCATION AND TO SEE THEIR CHILDREN PERFORM. ETM ALSO HELPED BRING QUALITY MUSIC EDUCATION TO OVER 22,000 ADDITIONAL CHILDREN THROUGH ADVISING LICENSED AFFILIATE ORGANIZATIONS IN LOS ANGELES, COLORADO AND BOSTON. CORE MUSIC INSTRUCTION AND ENRICHMENT STUDENTS IN ETM PARTNER SCHOOLS RECEIVED WEEKLY CORE MUSIC CLASSES DURING THE SCHOOL YEAR. TEACHERS INCORPORATED AGE-APPROPRIATE SONGS AND INSTRUMENTS SUCH AS: XYLOPHONES, HAND PERCUSSION, AND UKULELES. MIDDLE AND HIGH SCHOOL INSTRUCTION INCORPORATED MUSIC TECHNOLOGY IN STATE-OF-THE-ART LABS. INSTRUCTION FOLLOWED ETM'S GRADE-LEVEL MUSIC CURRICULUM, WHICH ALIGNS WITH NEW YORK STATE AND NATIONAL STANDARDS. IN ADDITION TO PROVIDING A FOUNDATION OF KNOWLEDGE AND SKILLS IN MUSIC, MUSIC TEACHERS EMPLOYED INTEGRATION STRATEGIES AND COLLABORATED WITH CLASSROOM TEACHERS TO REINFORCE COGNITIVE SKILLS THAT SUPPORTED STUDENT LEARNING IN OTHER SUBJECTS, SUCH AS ENGLISH LANGUAGE ARTS, HISTORY, MATH, AND SCIENCE. EACH SCHOOL PERFORMED A WINTER AND SPRING CONCERT, WITH A CULMINATING PERFORMANCE OF THEIR WORK. BY PERFORMING IN THESE CONCERTS, STUDENTS SHOWCASED THEIR NEW SKILLS AND ACCOMPLISHMENTS TO PEERS, PARENTS, AND THEIR WIDER SCHOOL COMMUNITIES. DURING 2022-2023, ETM CREATED TWO CURRICULUM INITIATIVES: ACTIVITY OF THE WEEK AND MONTHLY REPERTOIRE UNITS. THROUGH ITS ACTIVITY OF THE WEEK UNITS, ETM STAFF DEMONSTRATED HOW TO SCAFFOLD MUSICAL EXPERIENCES FOR GRADE PREK-2, 3-5, AND 6-8, WHILE INVOLVING ALL FOUR CATEGORIES OF MUSIC EDUCATION: CREATING, PERFORMING, RESPONDING, AND CONNECTING. IN THE MONTHLY REPERTOIRE UNITS, ETM PROGRAMS STAFF HIGHLIGHTED DIVERSE STYLES, COMPOSERS, AND TYPES OF MUSIC, AND MODELED HOW TO TEACH BENCHMARKS WHILE PREPARING A PIECE OF MUSIC FOR PERFORMANCE. THE TEAM ALSO EXPANDED ETM'S REPERTOIRE UNITS INTO GRADES 7-12. ETM CREATED 30 ACTIVITY OF THE WEEK GUIDES AND 23 REPERTOIRE UNITS WITH LINKED AND READY-TO-USE RESOURCES FOR ETM TEACHERS TO ADAPT TO THEIR SCHOOL, STUDENTS, AND TEACHING STYLE. ENSEMBLES AND ENRICHMENT THIS YEAR ETM CONTINUED TO SUPPORT THE ESTABLISHMENT AND GROWTH OF 30+ ENSEMBLES, INCLUDING BANDS, ORCHESTRA, AND CHOIRS. PARTICIPATION IN AFTERSCHOOL PROGRAMS, PART OF ETM'S "EXTENDED DAY," RESULTED IN OVER 600 STUDENTS PARTICIPATING IN THESE AFTERSCHOOL PROGRAMS FOR A TOTAL OF OVER 1,700 SESSIONS/HOURS. MUSIC TEACHER PROFESSIONAL DEVELOPMENT ETM PROVIDED OVER 100 HOURS OF TRAINING AND PROFESSIONAL DEVELOPMENT (PD) TO MUSIC TEACHERS, INCLUDING THE INTENSIVE, MULTI-DAY "ETM ACADEMY" BEFORE THE START OF THE SCHOOL YEAR AND ADDITIONAL SESSIONS THROUGHOUT THE YEAR. THESE 30 WORKSHOPS FOCUSED ON SOCIAL EMOTIONAL LEARNING, CONCERT AND PERFORMANCE ELEMENTS, AND CREATING INCLUSIVE CLASSROOMS, AMONG OTHER TOPICS. ETM ALSO HELD 15 REQUIRED PROFESSIONAL DEVELOPMENT SESSIONS OVER THE COURSE OF THE SCHOOL YEAR. THESE SESSIONS INCLUDED TEACHING MUSIC TO SPECIAL NEEDS STUDENTS, AUTHENTIC SONGS AND GAMES FROM COLOMBIA, MUSIC AND THE NEURODIVERGENT LEARNER, AND ANTI-RACIST PRACTICES, AMONG OTHER TOPICS. TO ADDRESS THE ONGOING IMPACTS OF THE PANDEMIC ON THE MENTAL AND EMOTIONAL WELL-BEING OF STUDENTS AND TEACHERS, ETM PARTNERED THIS YEAR WITH THE NEW YORK CITY CHILDREN'S THEATER ON A YEAR-LONG PROFESSIONAL DEVELOPMENT SERIES FOCUSED ON TRAUMA-INFORMED PRACTICES. WORKSHOPS EXPLORED STRATEGIES FOR PEER SUPPORT, SELF-CARE, BUILDING RESILIENCY, AND MODELING HEALTHY RELATIONSHIPS WITH COLLEAGUES, AS WELL AS TOOLS FOR STUDENTS TO EXPRESS THEMSELVES AND MANAGE THEIR EMOTIONS THROUGH MUSIC. ETM PROGRAM STAFF ALSO PROVIDED ONGOING SUPPORT AND MENTORING TO TEACHERS, VISITING EACH ETM TEACHER ON SITE AT LEAST ONCE PER MONTH, AND HOLDING REGULAR CHECK-INS. BUILDING CAPACITY TO SUSTAIN PROGRAMS PRINCIPALS RECEIVED ONE-ON-ONE GUIDANCE ON PROGRAM MANAGEMENT, ASSESSMENT, BUDGET PLANNING, AND IDENTIFYING FUNDING RESOURCES. ETM PROVIDED ONGOING SUPPORT TO PRINCIPALS DURING THE SCHOOL YEAR TO PROMOTE BUY-IN FOR MUSIC PROGRAMS. ETM STAFF AND MUSIC TEACHERS BUILD RELATIONSHIPS WITH SCHOOL PERSONNEL AND ENGAGED PARENTS. ETM'S MODEL IS SUCCESSFULLY COMPLETED WHEN THE SCHOOL HIRES A MUSIC TEACHER FULL-TIME. PUBLIC PERFORMANCES & PROGRAMMING DURING 2022-23, ETM STUDENTS PERFORMED AT THE ICONIC APOLLO THEATER, AT THE OFFICES OF YOUTUBE AND WARNER MUSIC GROUP, AT THE WORLD TRADE CENTER, AND AT YANKEE STADIUM. THIS YEAR ETM LAUNCHED MONTHLY PODCASTS TO EXPLORE THE PRACTICE AND IMPORTANCE OF MUSIC EDUCATION IN OUR SCHOOLS, AND RENEWED ITS PARTNERSHIP WITH WNET (NYC PBS TELEVISION STATION), CONTRIBUTING MUSIC LESSONS AND PROVIDING MUSIC EDUCATION BEYOND THE REACH OF ITS PARTNER SCHOOLS TO THE ENTIRE NYC POPULATION. AS PART OF THEIR WNET'S LET'S LEARN SERIES, ETM CREATED A SERIES OF VIDEO LESSONS TO GUIDE CHILDREN IN FUN AND INTERACTIVE MUSIC MAKING AT HOME AND IN THE CLASSROOM. FROM GAMES ABOUT PITCH, RHYTHM, AND MELODY, TO LESSONS INTRODUCING STUDENTS TO THE UKULELE, GUITAR, AND PIANO, THIS PARTNERSHIP ADVANCED ETM'S MISSION OF MAKING MUSIC EDUCATION ACCESSIBLE FOR ALL STUDENTS, IN AND OUTSIDE OF THE CLASSROOM. EVALUATION EACH YEAR, PROGRAM STAFF MEMBERS CONDUCT REGULAR SITE VISITS TO EACH SCHOOL AND MUSIC TEACHER; OBSERVE AND EVALUATE MUSIC TEACHERS USING A RUBRIC TO RATE PLANNING AND PREPARATION, CLASSROOM ENVIRONMENT, INTEGRATION, AND INSTRUCTION; AND DISCUSS OBSERVATIONS AND OFFER SUGGESTIONS FOR IMPROVEMENT. OUR OBSERVATION RUBRICS ALIGN WITH THE DANIELSON FRAMEWORK, THE SYSTEM USED BY THE NYC DOE. NATIONAL ACTIVITIES BEYOND CORE PROGRAMS IN NYC, ETM CONTINUED WORK TO ADVANCE ITS MODEL NATIONALLY THROUGH ITS LICENSED AFFILIATE PROGRAMS. ETM CONTINUED TO ADVISE ETM-LA, THE ORGANIZATION LICENSED SINCE 2006 TO REPLICATE OUR FULL PARTNER SCHOOL MODEL IN THE LOS ANGELES COMMUNITY. IN 2022-23, ETM-LA REACHED 19,000 STUDENTS IN 42 SCHOOLS, WHILE PROGRAMMING CONTINUED TO DEVELOP IN NEWER ETM AFFILIATES IN DENVER (ETM-COLORADO) AND BOSTON (ETM-MASSACHUSETTS), AND ETM CONTINUED RESEARCH AND OUTREACH AIMED AT DEVELOPING NEW POTENTIAL AFFILIATES IN ADDITIONAL CITIES.
