ETM DELIVERED MUSIC CLASSES TO OVER 18,000 CHILDREN AT 50 SCHOOLS IN LOWER-INCOME NEW YORK CITY NEIGHBORHOODS, PRIMARILY SERVING UNDERSERVED STUDENTS.
